

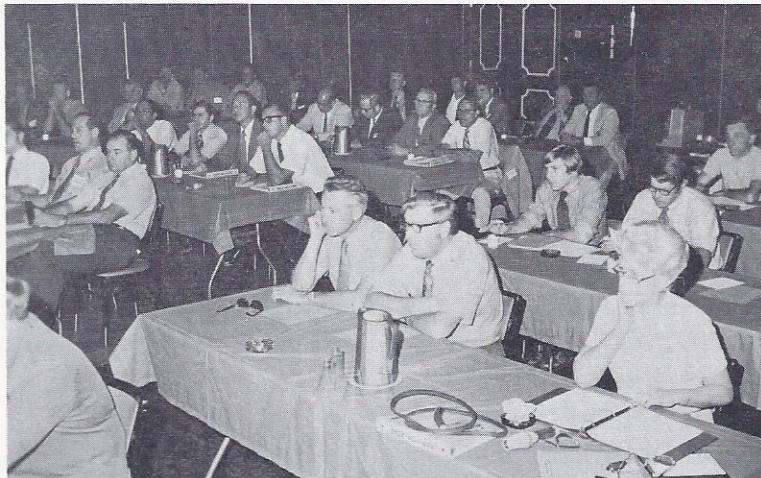

An Open Letter To All Hahn Employees.....

Subject: COMPENSATION CLAIMS

The processing of compensation claims is one of my duties to you as your plant nurse. The knowledge of even the seemingly most insignificant injury to any of the many Hahn employees is of my greatest concern. Several incidents have happened in the past year which have made me realize that it is necessary for me to make you aware, as an employee of Hahn, of the importance of reporting all work associated injuries or illnesses.

It is of the utmost importance, for an employee, to report to me any job related injury or illness immediately. If you cannot get to my office, please telephone me or write me a letter. Please do not be shy or negligent in the report of your situation. If for some reason I am not available, please report to your foreman or supervisor. Do not delay! Also report the date and time, as nearly as is possible, that you become aware of your illness or injury.

Let me describe one such incident in which no report of any kind was made to me. A young man, working in the riding mower assembly area lifted the front end of a mower frame and felt a pulling sensation in his back muscles. Five weeks later a bill for x-rays and out-patient hospital care amounting to \$67.00 was received. When this employee was called into my office, he could not remember the date of his injury or the name of the doctor treating him, even though he had been in the doctor's office on two different occasions. It is most difficult to file an insurance claim without such pertinent information.

Another incident involved an employee, working on a drill press, who became aware of a

backache that seemed to become more uncomfortable each day. This man did at least report his problem to me. After checking with his foreman and supervisor, some changes were made at his work station. There were no further complaints or discussions concerning this problem, after the initial report. I assumed the man's problem was solved. Seven weeks later, this employee brought in a doctor's bill for \$18.00, for three office visits to a doctor. I can only assume the visits were for a backache resulting from his situation at work.

I am sure the failure of these two employees and many others, to report their job related physical problems is not intentional. Whether it be intentional or not, it is quite possible employees should assume the payment of expenses incurred, if there has been no communication with the nurse's office. Remember, please come to me and discuss any physical problems before visiting a doctor, if the problem might be job related.

There will be further notices from the Personnel Office concerning this subject. Your Union officials will also be asked to encourage you to report your problems promptly. All of this is to help assure you of the care and treatment you may need. It is up to you to do your part.

It is my greatest concern to serve you with kindness and consideration, to keep you on the job, to provide you with some feeling of security, and to be ready the instant you need care.
